What is the 340B position on Referral Capture?

As a Covered Entity (CE) provider, you may refer a patient for a consultation to an outside clinic and consider that patient 340B eligible, as long as you maintain ongoing responsibility for care.

According to HRSA, the **definition of a 340B patient** is an individual who "...receives health care services from a health care professional who is either employed by the covered entity or provides health care under contractual or other arrangements **(e.g. referral for consultation)** such that responsibility for the care provided remains with the covered entity."¹ What is included in a successful referrals program?

The key to a successful referrals program is to to "close the loop" by creating a detailed Policies & Procedures framework which include these critical details:

- The definition of a 340B eligible patient;
- Roles and responsibilities of your team involved in the 340B program workflow;
- Ongoing provider education plans detailing Primary Care Provider (PCP) referral out and back so it's clear the PCP is responsible for continuing care;
- Internal workflow steps for 340B eligibility of referral prescriptions;
- Referral match testing & referral NPI provider maintenance as part of your ongoing self-auditing routine.
